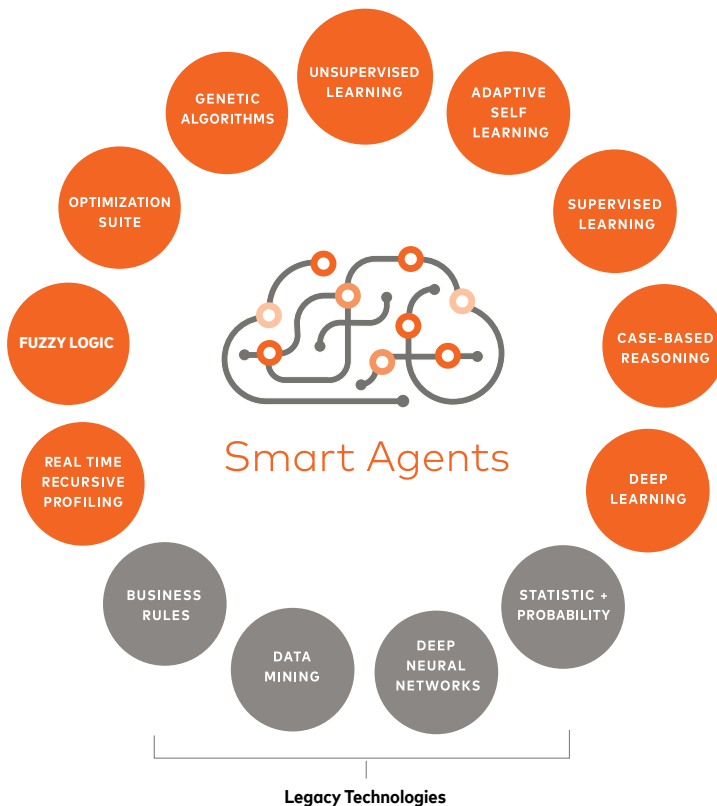

This one-to-one behavioral profiling provides unprecedented, omni-channel visibility into the behavior of an entity.
